4th RACE #1 "Juilliard" (Christopher A. Emigh) was injured in the starting gate and was a late scratch on the advice of the KHRGC veterinarian.

#7 "Yes I'm a Beast" (Albin Jimenez) finished fifth and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.


7th RACE Both #5 "Lend it Tewmey" (Edgar Morales) and #6 "Sutherland" Rafael Bejarano) were injured in the starting gate and were both scratched on the advice of the KHRGC veterinarian. A claim that had been submitted for #6 was voided.


8th RACE An objection was lodged by the rider of second place #3 "Amor Patriae" (Edgar Morales) alleging interference by the rider of the unofficial winner #7 "Furio" (Jose Ortiz) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.

9th RACE #9 "Yamato" (Gabriel Saez) was pulled up near the 3/8 pole and required the assistance of the KHRGC veterinarians and the horse ambulance. It was determined that the horse, who had unseated the rider and run loose briefly, had suffered a catastrophic injury to his left foreleg and he was humanely euthanized.
