1st RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering. Odd vs. Even wagering was not offered when only two horses with even numbers remained in after scratches, in conflict with the rules governing the wager. Vimael Torres, aboard #9 "Dontworryboutnothn" raised up early approaching the wire and finished third, beaten by a neck. A Stewards Hearing was scheduled for Torres to address the matter.

2nd RACE CLEAR

3rd RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

4th RACE Program correction - #6 "Dancewhenyoucan" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

5th RACE Voided claim - horse name misspelled


The claim of #10 "Protective" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6th RACE Both #3 "Shanett" (Gabriel Saez) and #4 "Spun Candy" (Mario Gutierrez) broke through the gate prior to the start, but the riders stayed aboard. The horses were caught by the outriders, examined and approved by the KHRG veterinarian, and reloaded. The eventual start was without incident.
