The horse was placed on the See State Vet list. A claim that had been submitted for the horse was voided.

#4 "Loot the Moon" (Chase Miller) was pulled up near the 1/8 pole and required the assistance of the KHRC veterinarian and the horse ambulance. It was determined that the horse was lame and he was placed on the See State Vet list.
