
- 3<sup>rd</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

An objection was lodged by the rider of second place #6 Jay Vee Bee" (Rafael Bejarano) alleging interference by the rider of the winner #5 "Shady McGee (IRE)" (Tyler Gaffalione) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that there had been no interference and the race was posted official.
