An objection was lodged by the rider of second place #5 "Sapphire Beach (IRE)" (Cristian A. Torres) alleging interference by the rider of the unofficial winner #7 "Essential Coffee" (Keith J. Asmussen) near the 7/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #7 angled in while not clear, causing #5 to clip heels, steady and lose momentum. For the interference #7 was disqualified and placed second, behind #5. Official order of finish: 5-7-1-3

The claim of #2 "Troubler" was voided pursuant RACE to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
