1st RACE #3 "Butterfly Jasmine" (Brian J. Hernandez, Jr.) was injured in the post parade and required the assistance of the KHRG veterinarians and the horse ambulance and was a late scratch on their advice. There was a 10 minute delay after the horse was vanned off while the track maintenance crew reconditioned the track. During the delay, the field continued to warm up without incident. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

#5 "Oscar Eclipse" (Francisco Arrieta) was a late scratch from the post parade on the advice of the KHRG veterinarian.
