INCIDENTS/INQUIRIES/OBJECTIONS

- **Race 3** → #10 Vitos Lady was placed on the Judges List – Repeated Breaks
- **Race 8** → #5 Blaze Shooter did make a break at the Top of the stretch causing a chain reaction involving #3 - #7 - #6 - #8. #5 Blaze Shooter and #6 Seentheotherside did hook wheels, and both Jordan Patton & Tony Hall were unseated. The Judges immediately flashed the Yellow Warning lights. The Outrider did an amazing job catching one of the loose horses and the other horse was caught on the backside by a group of horsemen. The Starting Car made its way to the downed drivers immediately to shield them from any oncoming horses. The Ambulance was held off track until it was deemed safe by the Presiding Judge and then they were instructed on how to proceed to the downed drivers. Tony Hall left the track under his own power and asked to be taken off his remaining drives for the day after being cleared by the Medical Team. Jordon Patton was taken off track by the Medical Team and transported to a nearby hospital for medical evaluation and was released later that night from medical care.
