The claim of #8 "Single Dot Yaht" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE CLEAR

4th RACE Odd vs. Even wagering was not offered when only two horses with even numbers remained in after scratches, in conflict with the rules governing the wager.

5th RACE #5 "Noroomformischief" (Danny Sheehy) was a late scratch from the post parade on the advice of the KHRG veterinarian.

8th RACE A Stewards Inquiry was posted involving the top two finishers in the stretch and, in addition, an objection was lodged by the rider of second place #7 "Raiding Party (IRE)" (Tyler Gaffalione) alleging interference by the unofficial winner #10 "Turner's Charm" (Ben Curtis) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined there was insufficient evidence of interference to warrant a disqualification. No action was taken and the race was posted official.
