1st RACE #6 "Miss Peabody" (Edgar Morales) BLED, was eased, and required the assistance of the KHRGC veterinarians and the horse ambulance. A claim that had been submitted for the horse was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list

5th RACE An objection was lodged by the rider of second place #9 "Geno's Myth" (Declan Cannon) alleging interference by the rider of the unofficial winner, #6 "Pierce Elevated" (Walter A. Rodriguez) near the 1/6 pole. An additional objection was lodged by the rider of fourth place #2 "Spy" (Carlos E. Franca) alleging interference by the rider of #9. After reviewing the race replay and the involed riders, the stewards determined that there had been no interference to #9 by the rider of #6, and that #2 steadied slightly while being passed by rivals on either side.

The claim of #10 "Le Chiffre" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6th RACE #4 "Our Favorite Son" (Lanfranco Dettori) was a late scratch from the post parade on the advice of the KHRGC veterinarian.

A Stewards Inquiry was posted involving the top 2 finishers in the stretch and, in addition, an objection was lodged by the rider of second place #3 "Hauunted Flame" (Gerardo Corrales) alleging interference by the rider of the unofficial winner, #8 "Suited and Booted" (Vincent Cheminaud) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #8 bore out repeatedly and made contact with #3 several times, impeding his progress. For the interference #8 was disqualified and placed second, behind #3. Official order of finish: 3-8-10-6-9
