1st RACE #2 "Mustique" (Mitchell Murrill) finished third while suffering an injury approaching the finish and unseating the rider just past the wire. She was caught by the outrider and required the assistance of the KHRGC veterinarians and the horse ambulance. After diagnostics were performed, it was determined that the filly had suffered a catastrophic injury to her right foreleg and she was humanely euthanized.

The claims of both #3 "She's No Angel" and #5 "Crank it Up" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

2nd RACE CLEAR

3rd RACE #9 "Fireblade" (Gabriel Saez) finished eighth and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the horse had suffered an injury to his left foreleg and he was placed on the See State Vet list.

4th RACE Dead Heat for SHOW

5th RACE CLEAR

6th RACE #13 "Moonlight Dash" (Jose L. Ortiz) was pulled up near the 1/16 pole and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the horse had returned lame and she was placed on the See State Vet list.

7th RACE The claim of #7 "Glen Airy" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

8th RACE CLEAR

9th RACE Voided claim - used stable name only

#5 "Nursekringedances" (Chris Landeros) was injured in the starting gate and was a late scratch on the advice of the KHRGC veterinarian.
