1st RACE #2 "Mustique" (Mitchell Murrill) finished third while suffering an injury approaching the finish and unseating the rider just past the wire. She was caught by the outrider and required the assistance of the KHRGC veterinarians and the horse ambulance. After diagnostics were performed, it was determined that the filly had suffered a catastrophic injury to her right foreleg and she was humanely euthanized.

The claims of both #3 "She's No Angel" and #5 "Crank it Up" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

3rd RACE #9 "Fireblade" (Gabriel Saez) finished eighth and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the horse had suffered an injury to his left foreleg and he was placed on the See State Vet list.
