The claims of both #6 "I Don't Get It" and #7 "Bestfriend Rocket" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE The claims of both #3 "Sharons Angels" and #6 "In Rainbows" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

7<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering. Odd vs. Even wagering was not offered when only two horses with even numbers remained in after scratches, in conflict with the rules governing the wager.

11<sup>th</sup> RACE An objection was lodged by the rider of fourth place #6 "Daring Madison" (Jose L. After reviewing the race replay and interviewing the riders, there was insufficient video evidence to confirm the claim.
