

## INCIDENTS / INQUIRIES / OBJECTIONS / JUDGES LIST

- Race 2 - #1 Tell Shows The Way was 4<sup>th</sup> placed 8<sup>th</sup> due to locking on a line and taking up abruptly in front of horses past the  $\frac{3}{4}$  mile marker causing confusion and interference to #3 and #4.
- Race 6 - #3 Whiskey Wow was 1<sup>st</sup> placed 5<sup>th</sup> due to no losing ground continually while off stride and running for an extend period of time, well over an 1/8 of a mile.
- Race 13 - #5 Lil Joe IV made a break before the  $\frac{1}{2}$  mile marker causing interference to #3 Esteem. #5 was 6<sup>th</sup> placed 7<sup>th</sup> behind the effected horse, and the race was allowed to go official.
- Race 13 - #1 It's A JK was placed on the Judges List – Did Not Meet Qualifying Time.
- Race 13 - #9 Miki Leaks was placed on the Judges List – Did Not Meet Qualifying Time.
