1<sup>st</sup> RACE A Stewards Inquiry was posted when #3 "Singsational" (Keith J. Asmussen) fell and unseated his rider approaching the 5-1/2 furlong pole. After reviewing the race replay and interviewing rider of fifth place #2 "Grove St." (Francisco Arrieta), the stewards determined that #3 appeared to clip the heel of that rival prior to the fall. There was no change in the order of finish and the race was posted official. The loose horse, who had been claimed, was caught by the outrider and sent to the test barn. It was later reported that the horse had suffered an injury that required treatment and the horse was placed on the Vet's list. The claim that had been submitted for the horse was voided. Asmussen was transported to the hospital for evaluation.
