The claims of both #1 "Pop Paul" and #8 "Dr. Niko" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

RACE #9 "Direct Channel" (Cristian A. Torres) finished eighth and required the assistance of the KHRGC veterinarians and the horse ambulance. It was later reported that the horse had returned lame and he was placed on the See State Vet list.

7<sup>th</sup> RACE CLEAR

8<sup>th</sup> RACE Program correction - #9 "Pursuitneversleeps" was mistakenly listed in the program to race with Lasix. The error was caught in a timely manner and the horse was permitted to race without the medication. The correction was posted and announced prior to the opening of wagering.

9th RACE An objection was lodged by the rider of third place #2 "Movin' On Up" (Lanfranco Dettori) alleging interference by both second place #9 "Charlene's Dream" (Rafael Bejarano) and the unofficial winner #8 "Pin Up Betty" (Luis Saez) near the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #2 lacked room while attempting to go between #8 and #9 in the stretch. There was no change in the order of finish and the race was posted official.
