1st RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

#1 "Pontiffany" (Francisco Arrieta) was a late scratch from the post parade on the advice of the KHRC veterinarian. The late scratch reduced the field to three necessitating the cancellation of the Exacta. Management also cancelled Place wagering. The mutuels department made the proper refunds.

2nd RACE Voided claim - no race number
Voided claim - insufficient funds

#1 "Gingrich" (James Graham) was pulled up abruptly inside the 1/16 pole and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that the horse had suffered a catastrophic injury to his left foreleg and he was humanely euthanized. 3 claims that had been submitted for the horse were voided.

3rd RACE An objection was lodged by the rider of fourth place #6 "Naughty Gal" (David Cohen) alleging interference by the rider of third place #5 "Holiday Decision" (Edgar Morales). After reviewing the race replay and interviewing the riders, the stewards determined that there was no interference and the race was posted official.





8th RACE Prior to the running of race 4 it was announced that this race would be contested at one mile on the main track.

#2 "Strollin the Bayou" (Francisco Arrieta) was a late scratch from the post parade on the advice of the KHRC veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

9th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.
