1st RACE CLEAR

2nd RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.
 #1 "Very Classy" (Vincent Cheminaud) was a late scratch from the post parade on the advice of the KHRG veterinarian.

3rd RACE #3 "Notary" (Francisco Arrieta) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

4th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.
 Odd vs. Even wagering was not offered when only two horses with odd numbers remained in after scratches, in conflict with the rules governing the wager.


5th RACE CLEAR


6th RACE #10 "Debt Paid" (Jaime A. Torres) finished seventh, suffered a post-race heatstroke, and required treatment from the KHRG veterinarians. The horse was placed on the See State Vet list.
