3rd RACE The entire plant lost power during the post parade. The horses were returned to the paddock, unsaddled, and remained there during the 50 minute delay that was due to a widespread area power outage. As soon as the power was restored, the horses were resaddled and returned to the track to warm up.

#1 "Anejo" (Reylu Gutierrez) was a late scratch from the eventual post parade on the advice of the KHRC veterinarian. The scratch reduced the field to five, necessitating the cancellation of the Superfecta. The mutuels department made the proper refunds.

4th RACE Prior to the running of race 4 there was a torrential downpour that necessitated additional track maintenance. The horses remained in the paddock during the 10 minute delay for the maintenance. Once it was completed, the race was run without incident.

The claim of #3 "Honeycomb" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
