TEST: 1<sup>st</sup> 2 & 6 (C 5), 2<sup>nd</sup> 7 & 9, 3<sup>rd</sup> 5 & 6, 4<sup>th</sup> 1 & 5, 5<sup>th</sup> 11 & 12 (C 2-voided & 9), 6<sup>th</sup> 7 & 8, 7<sup>th</sup> 2 & 4, 8<sup>th</sup> 10 & 12 (C 6), 9<sup>th</sup> 4 & 10.

3<sup>rd</sup> RACE #3 "Smart Remark" was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian.

4<sup>th</sup> RACE Voided claim - no date

5<sup>th</sup> RACE The claim of #2 "Ekati's Verve" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE CLEAR

7<sup>th</sup> RACE #5 "Sacred Oath" (David Cohen) trailed the field, was eased, and required the assistance of the KHRC veterinarians and the horse ambulance. The horse returned lame and as placed on the Vet's list.


An objection was lodged by the trainer (Brad Cox) of fourth place #2 "The Great Dansky" (Florent Geroux) alleging interference by the rider of third place #6 "Majestic West" (Gabriel Saez) in the stretch. After reviewing the race replay and interviewing the riders there was insufficient evidence to warrant a disqualification and the race was posted official.


