TEST: 1<sup>st</sup> 1 & 3 (C 4), 2<sup>nd</sup> 3 & 4, 3<sup>rd</sup> 3 & 7 (C 1, 2-voided & 4), 4<sup>th</sup> 5 & 9, 5<sup>th</sup> 4 & 5, 6<sup>th</sup> 1, 3 & 6, 7<sup>th</sup> 4, 6 & 13, 8<sup>th</sup> 7, 8 & 11, 9<sup>th</sup> 1, 2, 3 & 11, 10<sup>th</sup> 2 & 4, 11<sup>th</sup> 3, 4 & 5.

1<sup>st</sup> RACE #4 "Come Alone" (Martin Garcia) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian. A claim that had been submitted for the horse was voided.

2<sup>nd</sup> RACE CLEAR

3<sup>rd</sup> RACE Voided claim - owner name misspelled

#2 "Bodemeister Wind" (James Graham) was eased, finished well behind the field and required the assistance of the KHRC veterinarian and the horse ambulance. After diagnostics were performed it was determined that the horse had suffered a catastrophic injury to his left knee and he was humanely euthanized. The claim was voided pursuant to 810 KAR 4:050. The Horseman's Bookkeeper made the proper credits.

4<sup>th</sup> RACE #1 "Satin Rose" (Gabriel Saez) reared up and fell over in the post parade and was a late scratch on the advice of the KHRC veterinarian.

5<sup>th</sup> RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

#1 "All Fact" was a late scratch when the stewards were notified that she had suffered a serious injury in the barn area prior to being led to the paddock. The scratch reduced the field to four, necessitating the cancellation of the Trifecta. Management also opted to cancel Show wagering. The mutuels department made the proper refunds.


