The claim of #3 "Black Kat Taps" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE A Stewards Inquiry was posted when the rider of #6 "My Miracle Man" (Corey Lanerie) was unseated approaching the 1/8 pole. After reviewing the race replay and interviewing the riders of third place #2 "Tenth of Gold" (Ricardo Santana, Jr.) and second place #5 "Runpat" (Tyler Gaffalione), the stewards determined that #5 veered out in the stretch, making contact with #6, causing him to clip heels and unseat his rider. 10th RACE #3 "There Goes Harvard" (Tyler Gaffalione) broke through the gate prior to the start and unseated his rider. There assistant starter held onto the horse who was checked by the KHRC veterinarian and remounted. The start was without incident.

A Stewards Inquiry was posted when #3 "There Goes Harvard" (Tyler Gaffalione) unseated his rider leaving the 6 1/2 furlong pole. After reviewing the race replay and interviewing the riders of second place #4 "Surveillance" (James Graham), eighth place #1 "Kennedy's Beau" (Edgar Morales) and ninth place #6 "Boldish" (Gabriel Saez), the stewards determined that the rider on #3 caused his own trouble when he angled out behind #4 and clipped heels, causing his mount to stumble and unseat him. There was no action taken and the race was posted official.

Tyler Gaffalione was transported to the hospital but did not suffer a serious injury. The loose horse ran with the field and was caught without incident.
