1st RACE There was a 10 minute delay when a person suffered an injury in the paddock that required him to be transported from the facility by ambulance. The horses were held in the paddock until a substitute ambulance was in place.

3rd RACE The claim of #2 "Tidal Effect" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

8th RACE #5 "Makealittlemischief" was injured in the paddock and was a late scratch on the advice of the KHRC veterinarian.


A Stewards Inquiry was posted when #2 "Magic Star" (David Cohen) fell and unseated her rider going into the first turn. After reviewing the race replay the stewards determined that the horse reacted when in tight quarters, and that she had not been interfered with by a rival. There was no change in the order of finish and the race was posted official. A conversation with Cohen after the ordeal confirmed the stewards' findings. The rider was not seriously injured and the filly left the track on her own power and was attended to by the private veterinarian.
