1st RACE Voided claim - no owner listed

An objection was lodged by the rider of second place #3 "Seven Nation Army" (Julien Leparoux) alleging interference by the rider of the unofficial winner #6 "Palace Kitten" (Christian Torres) and also third place #5 "Derby Date" (Francisco Arrieta) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #5 drifted out and caused the slight interference while #6 stayed straight on the outside. Due to #3 finishing ahead of #5, there was no consideration to change the order of finish and the race was posted official.

2nd RACE CLEAR

3rd RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

4th RACE Voided claim - no funds

5th RACE The claim of #3 "Wartime Hero" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

#5 "Go for Sherrie" (James Graham) trailed the field and was pulled up before the finish line. The horse, who left the track on his own power, was placed on the Stewards List for poor performance.
