4th RACE #5 "Normandy Hero" (Tyler Gaffalione) unseated his rider in the post parade and ran loose for some time before finally being apprehended by the outriders. The horse was scratched by the stewards.

6th RACE A Stewards Inquiry was posted involving several horses in the stretch. After reviewing the race replay and interviewing the riders of the unofficial winner #8 "More Than Looks" (Cristian Torres), third place #4 "Miranda Rights" (Reylu Gutierrez) and fourth place #5 "Demolition Duke" (Brian Hernandez, Jr.), the stewards determined that #4 angled out and caused #5 to steady and lose momentum while #8 stayed straight on the outside. For the interference, #4 was disqualified from third and placed fourth, behind #5. Official order of finish: 8-10-5-4-11
