The claim of #8 "Miss Saipan" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE CLEAR

4th RACE #5 "Normandy Hero" (Tyler Gaffalone) unseated his rider in the post parade and ran loose for some time before finally being apprehended by the outriders. The horse was scratched by the stewards.

5th RACE CLEAR

6th RACE A Stewards Inquiry was posted involving several horses in the stretch. After reviewing the race replay and interviewing the riders of the unofficial winner #8 "More Than Looks" (Cristian Torres), third place #4 "Miranda Rights" (Reylu Gutierrez) and fourth place #5 "Demolition Duke" (Brian Hernandez, Jr.), the stewards determined that #4 angled out and caused #5 to steady and lose momentum while #8 stayed straight on the outside. For the interference, #4 was disqualified from third and placed fourth, behind #5.

7th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

8th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.
