Due to numerous late scratches reducing the field to three starters, the following wagers were cancelled; Super Hi-5, Superfecta, Trifecta, Exacta, Show and Place wagering. The mutuels department made the proper refunds.

8<sup>th</sup> RACE A Stewards Inquiry was posted involving several horses in the stretch. After reviewing the race replay and interviewing the riders of second place #9 "Bad Boy Frank" (Julien Leparoux), fourth place #3 "Le Bar" (Luis Saez) and #8 "Bandon" (Florent Geroux) who finished last, the stewards determined that #3 angled out made slight contact with #8 who steadied for a stride. When #9 angled out #8 appeared to not be able to keep up in his spot and the rider eased him. There was no change in the order of finish and the race was posted official.

9<sup>th</sup> RACE After the opening of wagering it was announced that this race would be removed from the turf and contested at one mile on the main track as specified in the conditions of the race. Due to numerous late scratches reducing the field to four starters, the following wagers were cancelled; Super Hi-5, Superfecta and Trifecta wagering. The mutuels department made the proper refunds.
