3rd RACE #7 "Heart of a Gunner" (Ben Curtis) flipped behind the starting gate and was a late scratch on the advice of the KHRG veterinarian.

4th RACE Voided claim - submitted in blank envelope

The claim of #6 "Evan on Earth" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE Odd vs. Even wagering was not offered when only two horses with even numbers remained in after scratches, in conflict with the rules governing the wager.

#9 "Bourbon Town" (Luis Saez), the winner, was pulled up abruptly after the race and required the assistance of the KHRG veterinarians and the horse ambulance. It was determined that the colt had suffered a catastrophic injury to his right foreleg and he was humanely euthanized.




7th RACE Super HI-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.


