2nd RACE An objection was lodged by the trainer (Justin Sherman) of fourth place #6 "Champagneome" (Ronney Betancourt) alleging interference by the rider of third place #3 "Candy Carlos" (Martin Garcia) in the stretch. After reiewin g the race replay and interviewin gthe riders. there was no evidence of interference and the race ws posted official.

The claim of #6 "Champagneome" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE #11 "Southern Sense" (Francisco Arrieta) ubseated his rider in the post parade, but the rider held onto the horse. The rider remounted and the race was without incident.


