1st RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

4th RACE #8 "Current Climate" (Corey J. Lanerie) was a late scratch from the post parade on the advice of the KHRGC veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

5th RACE Voided 2 claim - no date listed

The claim of #10 "Honky Tonk Highway" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

10th RACE A Stewards Inquiry was posted involving several horses in the stretch and, in addition, an objection was lodged by the rider of eighth place #9 "U Devil You" (Irad Ortiz, Jr.) alleging interference by the rider of third place #4 "Faust" (Keith Asmussen) and fourth place #5 "Keewaydin" (Cristian A. Torres) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #5 angled out and made contact with #4, forcing him into the path of #9 who checked sharply and lost all chance. For the interference, #5 was disqualified from fourth and placed eighth, behind #9.
