A Stewards Inquiry was posted involving several 10th RACE horses in the stretch and, in addition, an objection was lodged by the rider of eighth place #9 "U Devil You" (Irad Ortiz, Jr.) alleging interference by the rider of third place #4 "Faust" (Keith Asmussen) and fourth place #5 "Keewaydin" (Cristian A. Torres) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #5 angled out and made contact with #4, forcing him into the path of #9 who checked sharply and lost all chance. For the interference, #5 was disqualified from fourth and placed eighth, behind #9. Official order of finish: 11-2-4-8-3
