- Race 9 → #7 Look At Me did go inside more than 3 pylons after the ¾ mile marker and before the top of the stretch without cause and was 6th placed 7th for the violation.
- Due to the excessive heat index predicted in Southern Kentucky it was agreed upon by the KHRGC and Oak Grove that we started races at 9:00 AM and monitored the heat and all horses with the cooperation of the State Veterinarian.
