5<sup>th</sup> RACE #3 "Hornswoggle" (James Graham) bolted approaching the first turn, was pulled up and left the track on his own power. The horse was placed on the Stewards' List.

6<sup>th</sup> RACE An objection was lodged by the trainer (Michael Maker) of second place #10 "Strong Odor" (Ricardo Santana, Jr.) alleging interference by the rider of the winner #6 "Nightlife" (Gabriel Saez) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #6 drifted out and made slight contact with #10 who continued to be ridden and was not taken up or steadied. There was insufficient evidence to warrant a disqualification and the race was posted official.

7<sup>th</sup> RACE #7 "Take Charge Erica" (Martin Garcia) finished last and required the assistance of the KHRC veterinarians and the horse ambulance. It was determined that she had suffered an injury to her left hind leg and she was placed on the See State Vet list.
