1st RACE #2 "Yellow Brick" (Rafael Bejarano) was a late scratch from the post parade on the advice of the KHRG veterinarian.

The claim of #1 "Time for Trouble" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2nd RACE #7 "Rhinstone Runner" stumbled at the start, was pulled up shortly thereafter, and left the track on his own power. A claim that had been submitted for the colt was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE CLEAR

4th RACE #2 "Bartender" (Gabe Saez) broke through the gate prior to the start, unseated his rider and was quickly caught by the outrider. The horse was examined and approved by the KHRG veterinarian, remounted, reloaded, and the start was without incident.

5th RACE #6 "Special Caliber" (Luis Saez) finished third and required the assistance of the KHRG veterinarians and the horse ambulance. It was reported that the horse had returned lame and he was excused from the test barn. A claim that had been submitted was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
