2nd RACE CLEAR

3rd RACE Super Hi-5, Superfecta, Trifecta and Odd vs. Even wagering were not offered when the field was reduced to four prior to the opening of wagering. Management also opted to not offer Show wagering.

4th RACE The claim of #4 "Warrior Richard" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

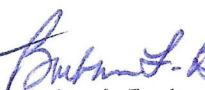
5th RACE CLEAR

6th RACE This race was taken off the turf and contested at one mile on the sloppy main track after a strong thunderstorm moved through the area and caused a 30 minute delay. The change of surface was posted and announced prior to the running of race 5. During the delay the horses remained in the paddock without incident.

7th RACE CLEAR

8th RACE This race was contested at 1-1/8 miles over the sloppy main track. Several late scratches due to the surface change reduced the field to eight, necessitating the cancellation of Jackpot 8 wagering. The mutuels department made the proper refunds.
