2nd RACE There was a 50 minute delay prior to the running of race 2 due to a storm with heavy rain and lightning in the area and the necessary track maintenance. Management made the decision to take the two scheduled turf races (4th and 8th) off the turf. Those changes were posted and announced prior to the running of race 2. During the delay the horses remained in the paddock. The race was eventually run over the sloppy track without incident.
