1<sup>st</sup> RACE Super Hi-5 and Superfecta wagering were not offered when the field was reduced to five prior to the opening of wagering.

The claim of #3 "Gold Search" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

2<sup>nd</sup> RACE There was a 50 minute delay prior to the running of race 2 due to a storm with heavy rain and lightning in the area and the necessary track maintenance. Management made the decision to take the two scheduled turf races (4<sup>th</sup> and 8<sup>th</sup>) off the turf. Those changes were posted and announced prior to the running of race 2. During the delay the horses remained in the paddock. The race was eventually run over the sloppy track without incident.

4<sup>th</sup> RACE CLEAR

5<sup>th</sup> RACE #8 "Outlier" (Mario Gutierrez) was a late scratch from the post parade on the advice of the KHRGC veterinarian. The scratch reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.
