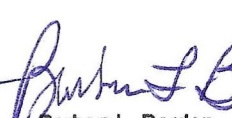

1st RACE #4 "Duke of Suggins" (James Graham) broke through the front doors of the starting gate, but the rider stayed aboard and the assistant starter held the horse in place. The doors were closed and the start was without incident.

A claim for #5 "Impavido" was voided due to the owner not being licensed. After the race, there was a shake for the horse with the remaining 18 claims that had been submitted. It was then discovered that the claim had been voided in error and that the owner was properly licensed for 2026. To correct the error, the stewards ordered a re-shake for the horse, who had just been released from the test barn to the winner of the 18 way shake. The stewards notified that trainer of the situation and instructed him to return the horse to the test barn. The shake was conducted and the horse awarded to owner Thomas A. Bickers.

The claim of #11 "Municipal" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRG Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

8th RACE #10 "Bourbon Story" (Julien Leparoux) finished fifth and suffered a post-race heatstroke. The filly, who required treatment from the KHRG veterinarians, was placed on the See State Vet list.

9th RACE Super Hi-5, Superfecta, Trifecta and Odd vs. Even wagering were not offered when the field was reduced to four prior to the opening of wagering. Management also opted to not offer Show wagering.
