2nd RACE Voided claim - incorrect date

#7 "Montauk Point" (Declan Cannon) finished sixth and suffered a post-race heatstroke. The horse required treatment by the KHRC veterinarians and he was placed on the See State Vet list.

3rd RACE CLEAR

5th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

6th RACE #6 "Overstatement" (Tyler Conner) was injured in the starting gate and was a late scratch on the advice of the KHRC veterinarian. Five claims that had been submitted for the horse were voided.


7th RACE A Stewards Inquiry was posted involving the stretch and, in addition, an objection was lodged by the rider of eighth place #2 "Cecile" (Jose Ortiz) alleging interference by the rider of the unofficial winner #8 "Dreaming of Mo" (Martin Chuan) near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #2 came out into #8 at the top of the stretch followed by some mutual contact, and that #2 lacked room and steadied slightly when she tried to overtake a foe to her inside near the 1/8 pole. There was no change in the order of finish and the race was posted official.


