TEST: 1<sup>st</sup> 2 & 4, 2<sup>nd</sup> 1 & 4 (C 3), 3<sup>rd</sup> 2 & 4, 4<sup>th</sup> 3 & 5, 5<sup>th</sup> 3-clm voided & 4, 6<sup>th</sup> 5 & 8, 7<sup>th</sup> 2 & 4, 8<sup>th</sup> 5 & 6, 9<sup>th</sup> 4 & 12.

DAY: CD at ELP - Day 37

1<sup>st</sup> RACE There was a 65 minute delay due to a strong thunderstorm that passed through the area. The horses were called to the paddock and remained unsaddled until the storm passed, the track was reconditioned, and the video crew returned to the camera towers. The race was eventually run without incident.

2<sup>nd</sup> RACE Superfecta and Trifecta wagering were not offered when the field was reduced to four prior to the opening of wagering.

3<sup>rd</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

4<sup>th</sup> RACE CLEAR

5<sup>th</sup> RACE The claim of #3 "Appeal Denied" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6<sup>th</sup> RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

This race was run at a distance of 1-3/8 miles on the main track as specified in the conditions of the race.

7<sup>th</sup> RACE The horses were returned to the paddock from the post parade when a thunderstorm quickly rolled into the area. During the 30 minute delay the horses remained in the paddock. After the storm passed, the track was reconditioned and the video crew returned to the camera towers. The race was eventually run without incident.
