An objection was lodged by the rider of third place #1 "Kahala" (Cristian A. Torres) alleging interference by the rider of second place #8 "All West" near the 1/8 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #1 steadled when he lacked room on the rall while attempting to go inside of #8. There was no change in the order offinish and the race was posted official.

A Stewards Inquiry was posted involving several 8th RACE horses in the stretch and, in addition, an objection was lodged by the rider of fifth place #6 "Xigera" (Julien Leparoux) alleging interference by both fourth place #5 "Occult" (Irad Ortiz, Jr.) and the unofficial winner #4 "Scylla" (Javier Castellano). After reviewing the race replay and interviewing all riders involved, the stewards determined that there was slight contact between #4 and #6 several times in the stretch before #6 angled in slightly and made contact with the hindquarters of #5 to her inside, causing #5 to turn in slightly which forced #6 to steady while in tight quarters. The objections against #4 and #6 were both disallowed. There was no action taken and the race was posted official.

An objection was lodged by the rider of third 10th RACE place #5 "Hoist the Gold" (Luis Saez) alleging interference by the rider of second place #7 "Angkor" (Jose Ortiz) in the stretch. After reviewing the race replay and interviewing the riders, the stewards determined that #5 actually came out and made contact with #7, followed by some slight mutual contact through the stretch. There was no change in the order of finish and the race was posted official.
