As the horses were loading in the starting gate for Race 2 it was discovered that there were several tractors on the racetrack performing additional maintenance on the muddy surface. The horses were quickly backed out of the gate and circled in the mile chute until the tractors were safely off the track. The incident caused an almost ten minute delay before the horses were reloaded and the race was run without incident.
