TEST: 1st 1, 4 & 6, 2nd 3 & 6, 3rd 3-clm voided & 4, 4th NO CONTEST, 5th 4, 5 & 6, 6th 3 & 4, 7th 2, 3 & 7, 8th NO CONTEST, 9th 2, 6 & 10.

1st RACE CLEAR

2nd RACE Superfecta, Trifecta and Show wagering were not offered when the field was reduced to four prior to the opening of wagering.

3rd RACE The claim of #3 "Ann in the Middle" was voided pursuant to 810 KAR 4:050 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE RACE DECLARED NO CONTEST

A Stewards Inquiry was posted shortly after the start when #2 "Zippy Baby" (Ricardo Santana, Jr.) hit and ran through the temporary turf rail, unseating his rider. The horse continued to run, causing a large portion of the rail to collapse. Because Santana was unable to be immediately moved and a large portion of the rail was down, the stewards took the necessary steps to have the field pull up by activating the alarm system and alerting the outriders. The horses were safely stopped near the 3/8 pole without incident and the race was declared a NO CONTEST. Both horse and rider escaped serious injury. Several claims that had been submitted in the race were voided. The mutuels department made the proper refunds.

5th RACE CLEAR

6th RACE Voided claim - track misspelled

7th RACE Superfecta wagering was not offered when the field was reduced to five prior to the opening of wagering.

8th RACE RACE DECLARED NO CONTEST

A Stewards Inquiry was posted shortly after the start when it was apparent that there had been a serious malfunction of the starting gate. All stall doors opened sporadically. After reviewing the replay of the start, interviewing the starter and each rider, the stewards determined that the race would be declared a NO CONTEST as the starting gate malfunction impacted the start of the participants who were all precluded from obtaining a fair start. The mutuels department made the proper refunds.
