4<sup>th</sup> RACE A Stewards' Inquiry was posted soon after the start involving #1 "Semble Juste (IRE) ridden by Brian Hernandez, Jr. who finished seventh after a troubled break from the starting gate. After reviewing the race replay and interviewing the starter and rider, the stewards determined that the horse had charged and opened the front doors and was being retrained by the assistant starter when the starter dispatched the field a split second later. The stewards declared #1 "Semble Juste (IRE) a NON-STARTER as he was precluded from obtaining a fair start. The mutuels department made the proper refunds.
