#5 "Tut's Revenge" (Cristian Torres) was a late scratch from the post parade on the advice of the KHRC veterinarian, Two claims that had been submitted for the horse were voided. The scratch reduced the field to four, necessitating the cancellation of the Trifecta. The mutuels department made the proper refunds.

RACE A Stewards Inquiry was posted when the riders of both #8 "Son of Thunder" (Jane Elliott) and #11 "Winger" (Martin Garcia) were unseated near the 5-1/2 furlong pole. After reviewing the race replay and interviewing the riders of several horses that were in the vacinity of the incident, it appeared that the two affected horses had gotten in a tangle and that no other horse or rider was involved. Since there was no evidence of interference no action was taken and the race was posted official.

#10 "Dreamwithinadream" (Javier Castellano) suffered a post-race heatstroke and required treatment from the KHRC veterinarians. The horse was placed on the See Vet list.

The claim of #6 "Gunner Bay" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.
