In addition, the rider of third place #4 "Kisses for Heidi" (James Graham) lodged an objection alleging interference by the rider of the winner #3 "Teenage Kicks" (Tyler Gaffalione) approaching the 1/16 pole. After reviewing the race replay and interviewing the riders, the stewards determined that #3 angled in nearing the 1/16 pole causing the #4 to check sharply and lose momentum. For the interference, #3 was disqualified from first and placed third behind #4. Official order of finish: 5-4-3-2
