1st RACE #4 "Crevalla de Vil" (Cristian A. Torres) finished fifth and suffered a post-race heatstroke that required treatment by the KHRG veterinarians. The filly was placed on the See State Vet list.

2nd RACE Super Hi-5, Superfecta, Trifecta and Odd vs. Even wagering were not offered when the field was reduced to four prior to the opening of wagering. Management also opted to not offer Show wagering. The changes were posted and announced prior to the opening of wagering.

#7 "Summonyourcourage" (Tyler Gaffalione) was a late scratch from the post parade on the advice of the KHRG veterinarian. The scratch reduced the field to three, necessitating the cancellation of the Exacta. Management also opted to cancel Place wagering. The mutuels department made the proper refunds.
