4th RACE The claim of #2 "Tres Soles" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

5th RACE There was a 20 minute delay prior to the running of race 5 due to a passing storm with heavy rain and lightning in the area and the necessary track maintenance. Management made the decision to take races 6 and 8 off the turf and those changes were posted and announced prior to the running of race 5. During the delay the horses remained in the paddock. The race was eventually run over the muddy track without incident.

The claims of both #3 "Suga Steve" and #5 "Tagliatelle" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

6th RACE After the race was taken off the turf, a late scratch for track condition reduced the field to six, necessitating the cancellation of the Super Hi-5. The mutuels department made the proper refunds.

7th RACE CLEAR

8th RACE After the race was taken off the turf, five late scratches due to track condition reduced the field to five, necessitating the cancellation of the Super Hi-5 and the Superfecta. The mutuels department made the proper refunds.
