The claims of #2 "We'll Do it Live", #3 "Tinki Abarrio", and #5 "Princess is Olivia" were voided pursuant to HISA Rule #2262 when the horses were placed on the KHRGC Veterinarian's list while In the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

The claim of #6 "Tempting Lady" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

The original claimant of #3 "Classic Legacy" (owner William A. Nichols) was found to be in possible violation of the regulation that governs claiming. The stewards voided the claim submitted by Nichols prior to the horse being released from the test barn. The remaining 8 owners who had submitted claims for the horse were included in a new shake. Following the shake, the partnership of W. Sparks, C. Monroe, K. Johnson and T. Patterson were awarded the horse.

The claim of #2 "Cape Trafalgar" was voided pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

6th RACE #2 "Writteninthesand" (Vincent Cheminaud), BLED, was eased and required the assistance of the KHRGC veterinarians and the horse ambulance. The filly was placed on the See State Vet list.
