1st RACE Volded claim - used stable name only

The claims of #2 "We'll Do it Live", #3 "Tinkl Abarrio", and #5 "Princess Is Olivia" were volded pursuant to HISA Rule #2262 when the horses were placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimants. The Horseman's Bookkeeper made the proper credits.

2nd RACE Volded claim - no funds

The claim of #6 "Tempting Lady" was volded pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

3rd RACE The original claimant of #3 "Classic Legacy" (owner William A. Nichols) was found to be in possible violation of the regulation that governs claiming. The stewards volded the claim submitted by Nichols prior to the horse being released from the test barn. The remaining 8 owners who had submitted claims for the horse were included in a new shake. Following the shake, the partnership of W. Sparks, C. Monroe, K. Johnson and T. Patterson were awarded the horse.

The claim of #2 "Cape Trafalgar" was volded pursuant to HISA Rule #2262 when the horse was placed on the KHRGC Veterinarian's list while in the test barn and prior to transfer to the claimant. The Horseman's Bookkeeper made the proper credits.

4th RACE CLEAR

5th RACE Super Hi-5 wagering was not offered when the field was reduced to six prior to the opening of wagering.

6th RACE #2 "WrittenInthesand" (Vincent Cheminaud), BLED, was eased and required the assistance of the KHRGC veterinarians and the horse ambulance. The filly was placed on the See State Vet list.


7th RACE Dead Heat for SHOW


8th RACE CLEAR
