<b>INCIDENTS/INQUIRIES/OBJECTIONS</b>

- **Race 6** → #3 Copesetic Sting was marked DNF as the horse attempted to pull up just after the start and again after the half mile marker when it refused to go.
- **Race 19** → #4 An Angel Somewhere did cause an interference break to #2 Show The Dragon just prior to the top of the stretch requiring #4 to be placed 2<sup>nd</sup> placed 4<sup>th</sup> behind #2 and all others being placed accordingly.
- **Race 20** → #1 Captain Crujido did cause interference while on a break to #3 Witness mark after the start in the first turn. #1 was 5<sup>th</sup> placed 6<sup>th</sup> behind #3.
- **Race 25** → #1 You're So Sweet made a break just before the top of the stretch causing interference to #4 Dowager & #5 Backseat Bettor. #1 was 3<sup>rd</sup> placed 5<sup>th</sup> behind affected horses and all others moved accordingly.
